**I acknowledge** that access to the SIS is granted with priority to LudoSport Affiliates, and that the categories of access have different features: *Instructors* have a maximum daily commitment of 6 hours of physical activity with a final exam (not mandatory, pass not guaranteed); *Specialists* have a minimum daily commitment of 4 hours of physical activity and they don't have access to the final exam; *Companions* have neither physical activity nor final exam; all categories have full board (accommodation plus three meals per day): extra food and beverages are not included. Travel is not included.

**I accept** and acknowledge that each attendee of Scuola Superiore Internazionale (SIS) needs to comply with the rules of the facility in which classes are hosted; accommodation will be in a room with twin beds; attendees must carry basic personal sports apparel; jockstrap is mandatory for males; a Starter kit will be offered to participants, with contents that may vary depending on items availability; lightsabers will be granted for the classes, and attendees will have them as a loan: sabers will be under attendees' responsibility and must return to the staff in good conditions; English will be the official classes language, while individual clarifications shall be possible outside of regular classes, as far as possible; the program of classes is given to attendees at the beginning of the

course and may vary according to needs of the teaching staff. Variations will be promptly communicated to attendees.

**I acknowledge** that all the techniques shown during the classes are intellectual property of the Society of LudoSport Masters and cannot be disclosed without written authorization. The Exam scheduled at the end of the Scuola Internazionale Superiore will allow teaching of sporting Light Saber Combat only within LudoSport affiliated Academies, with specifications and possible limitations indicated by SLM to the candidates, in case they pass the exam becoming Instructors. The evaluation of the Exams is unquestionable and final. Any qualified Instructor must wear an official Tunic (not included in the SIS fee) during teaching activity.

**I declare**, under my responsibility, not to have previous or current pending matters in relation to offences or facts that, even if not provided for as a criminal offence, may be connected or in reference: prostitution (also for aiding and abetting); paedopornography and crimes involving victims who are minors; criminal syndicates, drugs trafficking, weapons trafficking, human trafficking, terrorism; fraudulent accounting, forgery of documents or signatures, intellectual and industrial offences and in general crimes against industry and trade in general, IT fraud and IT or remote crimes; sexual violence, sexual abuse and mutilation of genitals; stalking; taking advantage of persons incapable; usury; abuse of popular beliefs.

**I accept** that attendees of SIS failing the Exam will not be authorized to carry out any teaching activity of sporting Light Saber Combat whatsoever, and in case of an appointment as LudoSport Instructor I commit myself to not carry out, for myself or on behalf of other subjects, identical or similar activities to LudoSport related ones, and in particular to not teach directly or indirectly, sports or game sporting disciplines that are similar to Light Saber Combat by way of their execution or background; to not commercialise products with a similar characteristic, appearance, type or other that are similar to the one commercialised by ABRIDGE srl brand LAMADILUCE; to not start up activities or sell products with trademarks, signs, symbols that may be confused with the ones used by LudoSport. The present agreement will remain in force for five (5) years from the termination date of LudoSport Instructor's appointment, stated by SLM on its own initiative or following a request.
